申請期間：4月1日～翌年2月28日 ※土日祝日を除く

補助額：対象経費の1/2以内（上限50万円）

※100円未満の端数切り捨て、当該年度の予算の範囲内で補助。

補助対象者


- ◇ 伊豆の国市商工会が実施する伊豆の国創業塾（個別相談を含む）を受けていること
- ◇ 市内で、創業または事業承継をしてから申請時点で1年以内であること
（実績報告の日までに創業又は事業承継をする場合は対象）
- ◇ 市町村税の滞納がないこと（転入等により当市の課税がない場合は、前住所地における滞納がないこと）
- ◇ これまでに、この補助金の交付を受けていないこと

補助金対象経費

- (1) 事業所として使用する建物の購入費
- (2) 事業所の増改築又は改修に要する経費
- (3) 備品購入費（税抜単価1万円以上）
- (4) 広告宣伝費
- (5) 法人設立時の登記に要する経費
- (6) 業務に必要なシステム経費
- (7) 事業所の家賃（最大6ヶ月）
- (8) リース費用（最大6ヶ月）
